PROPOSED 18-19 Calendar Adjustment

Currently, GLR is 27.25 hours short of the state required hours which requires $4 \frac{1}{2}$ days for make-up. The current approved 18-19 calendar listed make-up/snow days for May 22, 23, and 24.

The calendar committee met and discussed options regarding the school calendar due to the inclement weather for the remainder of the year. After careful review and discussion the committee recommends the following to the board for approval:

Current Make-Up Days:

- Full day of school May 22, 23, 24, and 28 as make-up days
- Request to waive ½ day on May 29
- May 29 would be teacher work day

If Additional Days:

- If additional days of inclement weather, add May 29, 30, and 31 as needed as student make-up days.
- Teacher work day would be day after the last day for students.
